#### REGULATIONS

## PAROLE REGULATIONS, DEPARTMENT OF HAWAII, GOVERNING PAROLED DETAINEES.

- 1. Upon the accomplishment of the necessary release and parole agreement, the detainees will be released from detention and may return to their homes and carry on their normal lives without restrictions other than those set forth in the parolee's agreement.
- 2. Parolees will be required to comply with all General orders of the Military Governor.
- 3. a Parolees will not engage in any activities contrary to Federal, Territorial, Municipal laws or regulations, General Orders of the Military Governor, or civil regulations issued by the Commanding General of the District in which they are residing.
- b Parolees will not engage in any action, movement, or endeavor that is deemed inimical to the interests of the internal security of the United States.
- 4. On the Island of Oahu, parolees will not travel from one police district to another without written authorization of the Oahu Parole Officer. In Districts other than Oahu, parolees will not travel from one part of the District to another without the written authorization of the District Parole Officer.
- 5. Parolees will not move from their permanent places of abode, or travel from one district to another without written authorization of the District Parole Officer.
- 6. Parolees will report at such intervals and such place as may be prescribed by the Chief or District Parole Officer.
- 7. Violation of these regulations or of the conditions of the parole prescribed by this headquarters, the Chief Parole Officer or the District Parole Officer, or any other action which may be deemed contrary to the best interests of the internal security of the United States, will subject the parolee to immediate revocation of his parole.
- 8. A copy of these regulations will be furnished each Sponsor and each Parolee.

#### RELEASE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS: I, SANJI ABE

residing at 2212 Kalanianaole Avenue, Hilo, Territory of Hawaii, was apprehended, arrested, detained, and confined on the 2nd day of SeptemberA.D., 1942, by the United States of America, officers, agents, and representatives thereof, upon suspicion of being dangerous to the safety of the United States, and have been detained and confined since said date;

NOW, THEREFORE, I request that I be released from custody, detention,

and confinement, without being detained, confined, or interned for the duration of the war, or for any period of time subsequent to the date hereof; and I, the said SANJI ABE in consideration of being released as herein requested and of being detained, confined, or interned no longer, and for other value received, for myself, my heirs, executors, administrators and assigns, hereby remise, release, and forever discharge the United States of America all departments, officers, agents, and representatives thereof, the Army of the United States, all departments, officers, agents, and representatives thereof, the United States Navy, all departments, officers, agents, and representatives thereof, and all other persons, and each of them, from any and all manner of action or actions, cause and causes of action, suit, controversies, tresposses, damages, judgments, executions, claims, claims for damages, and demands whatsoever, in law or equity, which against it, them, or him, or either or any of them, I have had, now have, or which my heirs, executors, or administrators, hereafter can, shall, or may have, for or by any reason of any matter, cause, or thing whatsoever because of or arising out of my being apprehended, arrested, detained, and confined as above stated, mentioned, and described, and because of my detention and confinement since the date of my said apprehension, arrest, and datention, up to and including the date of the execution of this release.
